

END-USER LICENSE AGREEMENT ("Agreement")

IMPORTANT: READ THIS LICENSE AGREEMENT BEFORE INSTALLING, ACTIVATING, OR USING THE SOFTWARE. THIS SOFTWARE LICENSE IS A LEGAL AGREEMENT BETWEEN YOU AND TREEAGE SOFTWARE, LLC ("TREEAGE"). BY INSTALLING, COPYING, ACTIVATING OR OTHERWISE USING THE SOFTWARE, YOU AGREE TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT INSTALL, ACTIVATE OR USE THE SOFTWARE.

1. Grant of License. This computer program (the "Software") and any copies that you make are owned by TreeAge. You are permitted to use the Software only as expressly provided in this Agreement. You agree to notify your employees and agents who may have access to the Software of the restrictions contained in this Agreement and to ensure their compliance with such restrictions.

2. Limitations on Use. One or more of the following paragraphs may apply, depending upon the license you have purchased:

(a) *Evaluation License.* If you have obtained a free Evaluation License, you may install the Software on only one (1) computer and use the Software only for evaluation purposes for a period of approximately 14 days (after which the Software will cease to function). If you want to use the Software for any other purpose or for a longer period, you must purchase an appropriate license from TreeAge. You may not attempt to extend the evaluation period through successive installations on one or more computers.

(b) *Single-User License.*

Single-user licenses must be registered under the name of the sole individual who will use the license. Any use by individuals other than the registered user is strictly prohibited, including sharing the same computer and any temporary transfer or use. See:

If you purchased a Single-User License, you may use the Software on only one (1) computer at a time.

Subject to the written certification (form of required certificate available at <<http://www.treeage.com/SecondAuth>>) that you will be the sole user of the Software, and the computer that it will be placed on, you may also have up to two (2) concurrent licensed installations the Software on computers belonging to you (for example, a laptop computer in addition to your desktop computer). The additional installation described in the preceding sentence is not available if you have a Student License or a Standard (perpetual) License with an expired Maintenance Agreement. Single-User Licenses may not be accessed remotely via a network, from a virtual machine, or by any other means. Such installations require a Network or Multi-user License. TreeAge Pro can only be installed and authorized on the computer of the registered user. Single-User Licenses cannot be installed on central or shared machines. If your Single-User License is an annual license, paragraph 2(h) shall also apply.

(c) *Multi-User Pack License*. If you have purchased a Multi-User Pack License, you may install the Software only on a number of your entity's own computers not greater than the number authorized by your license. The Software may not be installed on any additional computers (for example, laptop, home computers, or virtual machine). This license is an annual license. See paragraph 2(h) below.

(d) *Network License*. If you have purchased a Network License, you may install the Software on one (1) network server for concurrent use of the Software on multiple computers over that network. The number of concurrent users of the Software may never exceed the number of Software licenses purchased and assigned to your network. The Software may not be installed on any additional computers (for example, laptop or home computers). If your Network License is an annual license, paragraph 2(h) shall also apply.

(e) *Student License*. If you purchased a Student License, you may install the Software only on your own computer and you may use the Software only for your educational, non-commercial purposes. This license is an annual license. See paragraph 2(h) below.

(f) *Educational Site License*. If you purchased an Educational Site License, you may install the Software on any number of computers at the same school. Use of the Software is strictly limited to non-commercial, teaching purposes; this software is not, for example, licensed for research. If your Educational Site License is an annual license, paragraph 2(h) below shall also apply.

(g) *Beta Release or Pre-Release Versions*. If you have received a beta release or pre-release version of the Software, your license shall expire ninety (90) days from the date of its release (or such other period as indicated by the Software). See paragraph 2(h) below. TreeAge reserves the right not to release the Software commercially or to release a version of the Software having different features, specifications, capabilities, functions, licensing terms, release dates, general availability or other characteristics. You acknowledge that the beta release or pre-release version licensed to you is not suitable for production use and may contain errors affecting its proper operation.

(h) *Licenses with Limited Duration*. If your license is for a limited duration (an Evaluation License, an annual license or a beta or pre-release license), the Software will cease to operate at the conclusion of the license term. Information regarding whether your license is limited in duration and, if so, the expiration date of the license, may be found in the Software's License Manager, under the Help menu, or by contacting TreeAge via e-mail (support@treeage.com). You may not attempt to extend the life of Software licensed for a limited duration.

(i) *Licenses that are not time-limited*. If your license is a standard license, your Maintenance Agreement will be limited in duration. The expiration date of your Maintenance Agreement may be found in the Software's License Manager, under the Help menu, or by contacting TreeAge via e-mail (support@treeage.com). You may not attempt to extend the life of your Maintenance

Agreement to obtain features and capabilities that expire with your Maintenance Agreement such as technical support, upgrades and beta features.

(j) *License purchased with Academic Discount.* If your license was purchased at the discounted, academic price, the Software is not licensed, and may not be used, for any commercial, professional, or other for-profit purpose.

(k) *License purchased with Non-Profit/Government Discount.* If your license was purchased at the discounted, non-profit/government price, the Software is not licensed, and may not be used, for any commercial, professional, or other for-profit purpose.

(l) *Limited-Functionality Versions.* If your license is for a limited-functionality version of the Software (such as an Evaluation License, or certain other licenses), there are limitations imposed on various features, including model size and the ability to save files.

3. Prior Versions. If you have received the Software as an upgrade, then the upgrade replaces the Software previously licensed. The upgrade and associated license key do not constitute the granting of a second license to the Software, in that you may not use the Software upgrade in addition to the older version that it is replacing. Your license to use the Software is expressly conditioned on your deleting the older version of the Software from your computer and network within seven (7) days.

4. Technical Support. TreeAge will provide technical support ("Tech Support") at no charge to registered users of the Software in accordance with the following terms and conditions.

- (a) Tech Support shall be limited to (1) troubleshooting issues relating to installation of the Software, failure of the Software to function as specified in the User's Manual, and any other incompatibilities or bugs associated with the Software; and (2) reasonable assistance regarding efficient use of the Software's functionality.
- (b) TreeAge personnel who provide Tech Support are highly knowledgeable regarding the Software and its functionality. No claim of expertise is made, and Tech Support shall not be deemed to include (regardless of the actual content of any Tech Support communication) any advice or information, regarding (i) model content, structure, or design, (ii) which analytical functions should be employed in a given situation, or (iii) the interpretation of analytical results.
- (c) It is your responsibility to redact all proprietary or other confidential information from any model, information, or other materials, whether oral, written, or in any other form, imparted to TreeAge in connection with a request for Tech Support. By requesting Tech Support, you agree to indemnify TreeAge and hold TreeAge harmless in the event of any claim purportedly arising from, or otherwise alleging, receipt or use by TreeAge of confidential information in connection with Tech Support requested by, or furnished to, you.

(d) Tech Support will be based on the then-current version of the Software and will be furnished only to users who have licensed and installed the then-current version of the Software.

(e) If your License is time-limited, your right to receive Tech Support will expire when the License expires.

(f) If your License is not time-limited, your right to receive Tech Support will expire on the first anniversary of your purchase of the License or, if you have extended your right to Tech Support through purchase of a Maintenance Agreement, upon expiration of the most recent Maintenance Agreement.

5. Prohibited Uses. You may not: (a) rent, lease or otherwise distribute the Software; (b) alter, decompile, reverse-engineer, disassemble, translate or create derivative works from the Software; (c) attempt to modify or enhance the functionality of any version of the Software; or (d) make any copy of the Software not expressly authorized by this Agreement.

6. Export Controls. You acknowledge that the Software is subject to the export-control laws of the United States of America and other countries and you agree to comply with such laws. You may not, directly or indirectly, export or transmit the Software between any countries except in compliance with such laws.

7. Assignment. Your ability to assign your license to another party is limited as follows:

(a) You may not assign an Evaluation License in whole or in part.

(b) You may not assign a Network License, Multi-User Pack License or Educational Site License to any third party except as part of the sale of all or substantially all of the assets of your entity's business or non-profit activities, subject to paragraph 7(d) below.

(c) You may assign a Single-User License or a Student License to a third party, subject to paragraph 7(d) below.

(d) Any assignment permitted hereunder shall be subject to the following conditions: (i) the assignee would have been eligible to purchase the same type of license directly from TreeAge; (ii) you give prior written notice of the assignment to TreeAge, including pertinent information regarding the assignee; (iii) the assignee expressly agrees to be bound by all the terms of this Agreement; and (iv) you retain no copies of the Software (including associated license keys) or any accompanying materials.

8. Duration. The license granted hereunder will remain in effect unless and until it is terminated. Termination is automatic, without notice from TreeAge, if you fail to comply with any provision of this Agreement. Upon termination, you must delete or destroy all copies of the

Software and any accompanying materials. TreeAge explicitly reserves the right to enforce any other legal rights arising from your failure to comply with this Agreement.

9. Reservation of Rights and Ownership. TreeAge reserves all rights not expressly granted to you in this Agreement. The Software is protected by copyright and other intellectual property laws and treaties. TreeAge or its licensors own the title, copyright, and other intellectual property rights in the Software. The Software is licensed, not sold.

10. Third Party Software Licenses/Notices. Notices and/or additional terms and conditions for licensed third party software components included within the Software are provided at: <<http://www.treeage.com/products/legal3rdpartyrcp.html>>. These notices and/or additional terms and conditions are made a part of and incorporated by reference into the Agreement. Any provisions of the Agreement which differ from third party terms and conditions are offered by TreeAge alone and not by any third party.

11. Privacy and Your Information. Details of information that we collect and how we use it can be found in our Privacy Policy at <https://www.treeage.com/about-us/privacy-policy-web/>, which is a constituent part of and is incorporated by reference into the Agreement.

12. Warranty.

(a) *Warranty Disclaimer (Evaluation License only)*. The Software, and any and all accompanying materials, are provided "AS IS" and with no warranties of any kind, whether express or implied, including, without limitation, any warranty of merchantability or fitness for a particular purpose. TreeAge does not make any representation or warranty regarding the use of, or the results of the use of, the Software.

(b) *Limited Warranty (all other Licenses)*. TreeAge warrants that: (i) the Software will perform substantially as described in the relevant sections of the then current version of the TreeAge Pro™ User's Manual for a period of ninety (90) days from the date of purchase; and (ii) to TreeAge's knowledge, the Software, when used as provided and for the purposes intended by TreeAge, does not infringe the intellectual property rights of any third party. In the event of a breach of the foregoing warranties, your exclusive remedy shall be to return the Software and any accompanying materials to the place of purchase for, at TreeAge's option, a refund of any license fee you have paid for such Software during the twelve (12) months prior to your claim or replacement of the Software. This limited warranty states TreeAge's entire liability hereunder.

EXCEPT FOR THE WARRANTY SET FORTH ABOVE, THE SOFTWARE AND ACCOMPANYING MATERIALS ARE PROVIDED "AS IS" AND TREEAGE DISCLAIMS ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. TREEAGE DOES NOT WARRANT THAT OPERATION OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE OR THAT ANY DEFECTS IN THE SOFTWARE WILL BE CORRECTED. YOU ASSUME THE ENTIRE RISK AS TO THE RESULTS AND PERFORMANCE OF THE SOFTWARE. THE EXCLUSION OF IMPLIED WARRANTIES IS NOT PERMITTED BY

You hereby assume the entire risk of all use of the Software. This disclaimer of warranty constitutes an essential part of this Agreement.

In addition, in no event does TreeAge authorize you or anyone else to use the Software in applications or systems where the Software's failure to perform can reasonably be expected to result in a significant physical injury, or in loss of property, or loss of life. Any such use is entirely at your own risk, and you agree to hold TreeAge, its affiliates and licensors harmless from any and all claims or losses relating to such unauthorized use.

13. Limitation on Liability. IN NO EVENT WILL TREEAGE BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, RELIANCE, OR INDIRECT DAMAGES (INCLUDING DAMAGES FOR LOSS OF BUSINESS PROFITS, INFORMATION, OR USE) ARISING OUT OF THE USE OF, OR INABILITY TO USE, THE SOFTWARE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU. THE LIABILITY OF TREEAGE FOR ACTUAL DAMAGES FROM ANY CAUSE WHATSOEVER, AND REGARDLESS OF THE FORM OF THE ACTION (WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR OTHERWISE), WILL BE LIMITED TO THE PURCHASE PRICE OF THE SOFTWARE.

14. Indemnification. You will indemnify TreeAge against any and all claims, liabilities, damages and costs (including reasonable attorneys' fees) resulting from or related to your: (a) use of the Software other than in accordance with this License or the Software's accompanying documentation; (b) use of the Software in combination with other products, equipment, software, or data not provided by TreeAge; (c) use of any version of the Software other than the most current version made available to you; or (d) modification of the Software.

15. Severability. Should any term of this Agreement be declared void or unenforceable by a court, such declaration shall have no effect on its other terms.

16. No Waivers. TreeAge's failure to enforce any rights, or to take action in the event of any breach, under this License shall not be deemed a waiver as to subsequent enforcement of rights or subsequent actions relating to past or any future breaches.

17. Entire Agreement. This Agreement contains the entire agreement, and supersedes any and all prior understandings, written or oral, between you and TreeAge, with respect to its subject matter.

18. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of Massachusetts, USA.
